PART II- PROCEDURES

2) A discount of two percent (2%) of the municipal portion of the taxes shall be applied to the prepayment of property taxes in the months of January and February.

3) Discounts shall be processed on funds received up to and including the close of business on the last business day in February.

4) Discounts shall not be applied to pre-payment of local improvement levies.

UPCOMING RENEWALS FOR 2016

Dog Licenses—Dog licenses must be renewed each year that ownership continues. Renewal of dog licenses is due and payable to the Town of Rimby on the first day of January in each year and shall be for the period of January 1st to December 31, each year.

Business Licenses—No person within or partly within the Town shall be engaged in any business unless and until they have paid the prescribed fee and hold a valid and subsisting business licenses as set out in the Town of Rimby Business License Bylaw 873/11. Payment of the business licenses fee shall be made no later than the last business day of March, or the fee shall be doubled.
