Tax Installment Payment Plan

A taxpayer may elect to pay taxes on a monthly installment basis by signing an agreement with the Town on or before Dec 31st of the previous year for the following year provided all taxes, local improvement taxes, penalties and business license fees are fully paid on or before December 31st of the previous year.

The monthly installment agreement will include twelve (12) monthly payments due and payable on the 15th day of each month.

A taxpayer who has signed the monthly tax installment agreement and if their payments remain up to date shall not be subject to the penalty clauses as outlined in the Tax Penalty Bylaw 870/11.
