

Discussion	Administration prepared a survey in regards to the development of fiber opti- technology in the Town of Rimbey. The survey was made public on the Town's website on May 4, 2020 and included with the utility bills mailed to residents on May 4, 2020 The survey closed to additional submission at 4:00pm on May 20, 2020.
	215 individuals responded to the survey, representing 8.0% of the total population o Rimbey; 210 residents representing 20% of residential property owners and 32 business owners representing 17% of the non-residential property owners. 148 survey were submitted electronically, and 67 surveys were submitted via hard copy. Question 9 allowed for residents to provide a written response, as such all efforts were made to transcribe the written responses verbatim. A detailed summary of the survey responses are included as an attachment, including the verbatim written responses.
Options	 Financially engage with Missing Link to apply to CRTC for funding to construct a fiber optic network within the Town of Rimbey. Do not financially engage with Missing Link to apply to CRTC for funding to construct a fiber optic network within the Town of Rimbey. Postpone the investment commitment to a future round CRTC funding applications. Investigate other options to improve internet service in the Town of Rimbey.

Rimbey	REQUEST FOR DECISION
Financial Implications	 If Council decides to proceed with the partnership with Missing Link, funds of approximately \$700,000 would be required when the CRTC grant is approved. Missing Link expects this would be in 2021 or 2022. Options to fund the project are as follows: a) Fund the \$700,000 from reserves. If the funding was to come from reserves several projects in the 5 year Capital Plan would have to be postponed until the reserves could be replenished. b) Secure a loan for \$700,000. Payments on a loan repayable over 15 years based on the current interest rate of 2.278% are \$55,356 per year. The loan payments will be part of the annual operating budget and will need to be funded by either a tax increase or a reduction of services until Missing Link begins to repay the investment.


Q1 Are you a resident of the Town of Rimbey?





Q2 Are you a business owner in the Town of Rimbey?






Q3 What is your age?

Q4 As a resident of the Town of Rimbey, are you satisfied with the current internet options available in the Town?







Q6 Do you support the Town of Rimbey partnering with a private sector business to construct a fiber optic network throughout the Town of Rimbey?





In past the Town has experienced damage to town infrastructure in a number of ways, including the improper loading unloading of building supplies resulting in damages to sidewalks and heavy trucks driving on roads and laneways which are not designed for heavy truck traffic causing damages to these road surfaces. As per the letter submitted by Mr. Bremner, he is requesting Council waive the refundable security deposit during these difficult times as he does not have the funds for both the project and the deposit. Mr. Bremner also notes that "I am a concrete finisher by trade and highly skilled skid steer operator who will be using a CAT249D model rubber track machine to prep the area which will greatly reduce the probability of any damage. I will also fix any chips in the curb if that occurs as I do not want


