A Tax installment plan is an option for those taxpayers who wish to pay their taxes on a monthly basis.

Monthly tax installments can be automaticallv withdrawn from a chosen bank account or by postdated cheques. In order to qualify for this plan, previous years taxes must be paid in full.

An agreement can be completed at any time of the year with the understanding that all prior months' payments be paid in full as of the date of the agreement.

Town Information and Events:

Peace Officer

All complaints must be made in writing to the Peace Officer. Although complaints must be made in writing, all complaints are confidential. The Peace Officer requires your contact information so he can follow up to get more details and keep you informed about the progress of a file. Once a complaint has been submitted in writing, you will likely be contacted to confirm details. If the file requires the action of the Peace Officer, he begins the process of trying to reach a resolution. The most important step in the process is the first step which involves the public bringing the problem to our attention. The Peace Officer is responsible for enforcing municipal regulatory bylaws and has jurisdiction to enforce provincial legislation within the Town of Rimbey boundaries for Environmental Protection and Enhancement Act, Part 9, Division 2; Provincial Offences Procedure Act and Moving traffic violations found within the Traffic Safety Act. Enforcement form can be found on the Town Website and must be submitted to the Town Office during regular office hours.

The Committee is open to community organizations who wish to provide information about their event, receive feedback/support and possibly partner with other organizations to enhance their event. Rimbey Recycle Facility

The Recycle Facility is open five days a week from Tuesday to Saturday, 10:00 am to 6:00 pm, located at the former transfer site. All material to be disposed of will be monitored by the site attendant and will need to be sorted and placed in the proper areas. Any material not acceptable at the new site will need to transported to the Bluffton Landfill. Please remember to secure all loads, as unsecured material that falls onto the road endangers other drivers and creates litter, which is unsightly and bad for the environment. The facility takes only the following recyclable materials:

- **Paper** newspaper, magazines, catalogues, white and computer paper, Christmas cards, non foil gift wrap, junk mail, paper bags, envelopes, paper egg cartons, paperback and books (remove hard cover), phone books.
- **Cardboard** flattened corrugated boxes, flattened cereal and food boxes (remove and discard liner), juice boxes, milk cartons (rinse with cold water and flatten), flattened shoe boxes and brown paper bags
- Metals (no loose lids, trap inside can or discard) clean tin cans (soup, juice, etc.), Aluminum containers (pie plates), aluminum cans (beverage), empty non-hazardous aerosol cans.
- Glass (empty and clean; discard lids green, brown and clear) jars (example pickle, jam, etc.) and bottles (all beverages) Note no ceramics, plate glass or mirror.
- Plastics (discard caps and lids; empty and rinse) household cleaner bottles, shampoo and conditioner bottles (including similar personal care products), vinegar bottles, plastic bags (all types including bread and dry cleaner bags), pop and beverage bottles, milk jugs, detergent or fabric softener bottles, margarine and yogurt containers, ice cream pails (remove metal handle), vitamin bottles, windshield washer containers.
- Yard Waste Acceptable yard waste includes only leaves, grass, hedge clippings, brush or tree trimmings to a maximum length of five (5) feet and a maximum diameter of six (6) inches, and Christmas trees. Yard waste must be removed from plastic bags or other containers and placed in the designated areas set out by the attendant.
- **Give and Take Exchange** any items for this area will need to be reviewed by the attendant before drop off.
- White Metals hot water tanks, stoves, wasters, dryers, dishwashers, fridges, deep freezes, etc. (all refrigerant must be removed and proof provided before acceptance)
- Concrete, asphalt, wood waste (restrictions will apply), metal, and tires.

Rimbey Aquatic Centre Update

Work continues at the Rimbey Aquatic Centre as supplies arrive on site. This week the pool m e m b r a n e w a s installed in the main pool basin. Lights and ladders will be the next to be installed. Work will also begin on installing the two hot tubs already



located on site. The fencing will be completed and railings will be added to the front entrance stairs and ramp that were poured a few weeks ago. The lime green waterslide is due to arrive soon.

Park and Playground Planning

The Recreation Board held a public meeting on June 15th to discuss the re-development of the BMX Park on 56th Avenue. We had approximately 20 people attend to provide their input as to what they would like to see at the park. The Board received many suggestions, including a hockey/basketball pad, new playground, walking trail and an improved BMX course. The Board will present their suggestions to a landscape architect to create a concept plan. The plan will then be presented to the public. A safety inspection was conducted on all Town-owned playgrounds on June 27th. The Town is awaiting a report from the company.

Rimbey Transfer Site Clean up

The Town of Rimbey is working in conjunction with Alberta Environment on the clean up of the transfer site. Arrangements have been made to have the burn pit material cleaned up and hauled to the Bluffton Landfill site for disposal, which should be completed some time in July. A clean burn pit will be constructed in accordance with regulations set out by Alberta Environment at the former site which is now the Recycle Facility.


