#### <u>BY\_LAW NO. 198</u>

A BY-LAW of the TOWN of RIMBEY to be known as THE CURFEW BY-LAW

WHEREAS the Council of the Town of Rimbey deem it necessary to change the previous CURFEW by-law in respect to children not under

proper guardianship;

NOW THEREFORE, the Council of the TOWN of RIMBEY, duly assembled,

ENACTS AS FOLLOWS:

- 1. This By-Law may be cisted as "THE CURFEW BY-LAW";
- 2. No child under the age of sixteen (16) years of age shall be in a public place in the Town of Rimbey without the proper guardianship after the hour of Ten O'Clock in the afternoon of any school day except on Friday, and allother nights after the hour of Eleven O'Clock p.m.;
- 5. No parent or guardian of a child under the age of sixteen (16) years of age shallallow that child to be in a public place in the Town of RIMBEY withput proper guardianship after the hour of Ten O'Clock in the afternoon of any school day except Friday. And all other nights after the hour of Eleven O'Clock p.m.;
- 4. If any child is found in breach of the provisions of this By-Law
  - (a) he or she may be directed by any Constable or other Peace Officer of the Town to immediately go to his or her home, and if after such warning the child refuses or fails to go home such child may be taken to his or her home or to a shelter by the Constable or Peace Officer;
  - (b) A C<sub>onstable</sub> or Peace Officer of the Town may contact that child's parent or guardian and direct he or she to immediately take into custody the child.
- 5. If in the opinion of a Constable or other Peace Officer a child repeatedly contravenes the provisions of this By-Law he may direct the parent or guardian of the child to immediately control the activities of the child to prevent further contravention of the child thereof.
- 6. For the purpose of the provisions of this By-Law the question as to age or proper ghardianship of the child shall be in the discretion of the Constable or other Peace Officer of the Town.
- 7. A parent or guardian who permits his child to contravene the provisions of this By-Law is guilty of an offence and liable to summary conviction for a first offence to a fine of five dollars, (\$5.00), and for a second offence to a fine of Ten dollars (\$10.00), and for a subsequent offence to a fine of twenty dollars, (\$20.00), and in each case in default of payment to a term of imprisonment of not more than three (3) months.
- 8. By-Law No. 141, being a previous Curfew By-Law and all subsequent amendments thereto are hereby appealed.

## BY-LAW NO. 269

A BY-LAW PROHIBITING THE USE OF STREETS FOR DISPLAY PURPOSES. In accordance with the provisions of Section 321(b) of The Town and Village Act, the Council of the Town of Rimbey, duly assembled, ENACTS AS FOLLOWS:

That no goods or merchandise shall be displayed, offered for sale or placed out for sale on any street, lane or other public place within the limits of the Town of Rimbey.

#### BY - IAW NO. 393

#### A BY-LAW TO PROVIDE FOR THE LICENSING OF MOBILE HOMES

Under the authority and subject to the provisions of Sections 2(nl) and 329 b of The Town and Village Act, being Chapter 338 of the Revised Statutes of Alberta, 1955 and amendments thereto, the Council of the Town of Rimbey, HEREBY ENACTS:

#### Interpretation: In this by-law,

÷.

- 1. (a) "Inspector of Mobile Home Licenses" means a person or persons appointed by resolution of the Council, pursuant to Section 91 of The Town and Village Act as inspectors of Mobile Home Licenses;
  - (b) "Mobile Home" means any vacation trailer or house trailer that is
    - (1) designed for or intended to be equipped with wheels whether or not it is do equipped, and
    - (ii) constructed or manufactured to provide a domicile fm: for one or more persons, but does not influde a trailer otherwise designated;
  - (c) "Owner" includes a person renting a mobile home or having the exclusive use thereof under a rental agreement or otherwise, or who domiciles himself, his family or any other person within a mobile home.

#### General Provisions:

- 2. No person shall occupy a mobile home in the Town of Rimbey for any period exceeding forty-eight (48) hours unless and until he has obtained from the office of the Secretary-Treasurer of the Town of Rimbey, a mobile home license.
- 3. All mobile home licenses sold under the provisions of this by-lsw shall be for the calendar year and shall expire upon the 31st day of December following the date of the issuance thereof.
- 4. The license shall be issued in the name of the person occupying a mobile home but may, upon proper notice being given in writing to the pecretary-Treasurer or other authorized person, be transferred to a person who subsequently becomes the occupier of the mobile home.
- 5. The Secretary-Treasurer of the Town of Rimbey is hereby empowered pursuant to the provisions of section 329b of The Town and Village Act or Section 323a of The Municipal District Act( as the case may be), to enter into agreements with occupiers of mobile homes, whereby payment to the Town of Rimbey of the annual **license** fees may be made on a monthly basis, provided however that such payments shall be payable in advance on the 1st day of each month. It is further provided that when the pccupier of a **mobile** home fails to make monthly payments as provided for in an agreement as aforesaid, the agreement shall become null and void and the remaining unpaid balance of the license fee shall immediately become due and payable.

If a mobile home in respect of which the annual license fee has been paid ceases to be occupied as such, or is remuved from the Town of Rimbey, the holder of the license for the said mobile home, upon application to the Secretary-Treasurer may claim a refund of the balance of the yearly license fee, the refund to be calculated

on the basis of 1/12th of the annual license fee for each full month remaining in the year.

- 7. The license fee shall be in the amounts as provided in the Schedule "A" appended to and forming part of this by-law.
- 8. Any person who commits a breach of any of the provisions of this by-law shall be liable upon summary conviction thereof, by any court of competent jurisdiction to a fine not exceeding one hundred (\$100.00) dollars and costs, and in default thereo to imprisonment with or without hard labor in the nearest common gaol for a period not exceeding 30 days unless such fine and costs, including the costs of committal are sooner paid and in addition to imposing a fine as hereinbefore provided, the convicting Justice may require a person convicted under this by-law to obtain a mobile home license.
- 9. This by-law and schedule "A" thereto shall continue in force from year to year until amended or appealed.

Mobile homes within the provisions of this section shall be further divided for the purposes of this schedule, into four separate and distinct groups, namely;

- <u>GROUP 1.</u> Units not manufactured commercially and of a non-professiona quality of construction.
- GROUP 2. Units of commercial or of professional quality of construction, manufactured prior to 1952;
- <u>GROUP</u> <u>3.</u> Units of commercial or of professional quality of construction, manufactured in 1952 or thereafter and not exceeding eight (8) feet in width.
- <u>GROUP 4</u> Units of commercial or of professional quality of construction and exceeding eight (8) feet in width.

The length of a mobile home subject to this Schedule shall be computed as the measured distance between the outermost extmemeties from front to ream, including any hitch or extension affixed for towing purposes.

#### BY-LAW NO. 543/88

A BY-LAW OF THE TOWN OF RIMBEY, IN THE PROVINCE OF ALBERTA, TO REQUIRE THE OWNER OR OPERATOR OF EVERY LICENSED MOBILE UNIT PARK IN THE MUNICI-PALITY TO NOTIFY THE LICENSE OFFICER BEING THE TOWN MANAGER OF THE MUNICIPALITY ON THE ARRIVAL AND DEPARTURE OF MOBILE UNITS.

WHEREAS, Section 236 Subsection 8 of the Municipal Government Act being Chapter M-26 of the Revised Statutes of Alberta, 1980 provides that a Municipality may pass by-laws requiring the owner or operator of a licensed mobile unit park to provide information to the license officer, being the Town Manager of the municipality regarding the arrival and departure of mobile units; and

WHEREAS, it is deemed necessary that the owner or operator of the licensed mobile unit park in the municipality co-operate with the license officer of the municipality in order that the collection of current and outstanding license fees may be made possible.

NOW THEREFORE, the Municipal Council of the Town of Rimbey duly assembled hereby enacts as follows:

- (1) That the owner or operator of every licensed mobile unit park in the municipality be required to notify the license officer, being the Town Manager of the municipality in writing of:
  - (a) the name and address of the owner of each mobile unit in the mobile unit park within 14 days of its being occupied, and
  - (b) any change of ownership or occupancy or any removal of a mobile unit from the park within 14 days of the change or removal.
- (2) Contravention of all or any part of this by-law shall be referred to By-Law #306/78 ("General Penalty By-law of the Town of Rimbey") for penalization.

(3) This by-law shall take effect immediately after being passed.

#### BYLAW #633/95

A BYLAW OF THE TOWN OF RIMBEY IN THE PROVINCE OF ALBERTA TO AMEND GENERAL PENALTY BYLAW #306/78.

WHEREAS the Council of the Town of Rimbey deems it desirable to amend Town of Rimbey General Penalty Bylaw #306/78;

NOW THEREFORE the Council of the Town of Rimbey, duly assembled, hereby enacts that General Penalty Bylaw #306/78 is amended by the addition of the following clauses:

- 6. Offences against any Town of Rimbey bylaw shall be processed by summons in the prescribed form as outlined in Part II of the Provincial Offences Procedure Act, R.S.A. 1988, Chapter P-21.5.
- 7. Fines processed will be in the prescribed form of a violation ticket or information as outlined in the Provincial Offences Procedure Act.
- Enforcement of municipal bylaws may be done by any member of 8. the Royal Canadian Mounted Police or the Town of Rimbey's bylaw enforcement officer.

This bylaw shall come into effect on the date of final passage thereof.

#### BY-LAW #306/78

## GENERAL PENALTY BY-LAW OF THE TOWN OF RIMBEY

WHEREAS, under the authority and subject to the provisions of the Municipal Government Act, being Chapter 246 of the Revised Statutes of Alberta 1970, and amendments thereto, specifically Section 115; and

WHEREAS, there are existing Town By-laws which have no penalty upon conviction for a contravention of them;

NOW THEREFORE, the Municipal Council of the Town of Rimbey, duly assembled, enacts as follows:

- (a) A maximum fine of \$500.00, exculusive of costs, which shall be imposed by a Court upon conviction for a contravention of any Town of Rimbey By-laws not stipulating a maximum fine.
  - (b) A maximum imprisonment of six months in case of non-payment of the fine and costs imposed for any such conviction for a contravention of any Town of Rimbey By-laws not stipulating a maximum imprisonment, unless the fine and costs including the costs of committal are sooner paid.
- (a) A minimum fine of \$25.00, excusive of costs, which shall be imposed by a Court upon conviction for a contravention of any Town of Rimbey By-laws not stipulating a penalty.
  - (b) A minimum imprisonment of five days in case of non-payment of the fine and costs imposed for any such conviction for a contravention of any Town of Rimbey By-laws not stipulating a penalty, unless the fine and costs including costs of committal are sooner paid.
- 3. A minimum daily fine of \$50.00 for every day the offense continues after conviction, exclusive of costs.
- Costs shall include any licence fee imposed by the Town of Rimbey and shall be recovered and enforced with the cost of summary conviction by the Court.
- 5. Any penalty or fine and costs under Town of Rimbey By-laws belongs to and forms part of the general revenue of the Municipality of the Town of Rimbey.
