**Important Notice to Residents
Water/Sewer Invoices**

Please be advised, during the Council 2017 Budget deliberations held November 19, 2016, Council passed Motion 476/16 with regards to Town of Rimby Water Services. Presented in the budget was an increase to the water rate per cubic meter from \$1.99, to \$2.02 effective January 1, 2017.

For your information a cubic meter of water is equivalent to 1000 litres. So, this means for every 1000 litres of water you use, you will be paying an additional \$0.03 cents.

For example, a utility bill with a consumption of 16.00 (16000 liters of water used) will now cost \$32.32 instead of \$31.84. A utility bill with a consumption of 10.0 (10,000 litres of water used) will now cost \$20.20 instead of \$19.90.

To put this in perspective, if you were to purchase one 1 litre of bottle of water at the store, it would cost you in the neighborhood of \$1.00-\$2.10. 1000 litres of water purchased on your utility invoice will cost you \$2.02.

The sewer rate remains the same at 70% of consumption of water.

PART II – PROPOSED TEXT AMENDMENT

Section 12.7(5)(a)(ii) shall be amended to read:
6.0 m from the rear lot line of the manufactured home park.

Section 12.7(5)(a)(iii) shall be amended to read:
2.4 m from any internal access road or common parking area.

Section 12.7(5)(a)(iv) shall be added to read:
1.2 m from the front lot line of the manufactured home park.
