Mayor Barr commented that at this time the lane is not currently utilized by vehicle access and has been maintained by the land owners and not the Town in a grass state. In the original subdivision the area was zoned residential and future residential development would have required a lane access.

Mr. Johnson would like to have a little more time before the application for lane closure proceeds. Mayor Barr thanked all in attendance and after the public meeting Council will discuss whether to delay reading of the bylaw.

# Public Presentation -John & Barbara **Jennings**

Area residents of 51st Avenue between 46 and 44 Street presented a letter they wrote to the Premier regarding the road repair needed in front of their properties. The property owner received responses from the Premier, Minister of Infrastructure and Transportation, and Minister of Municipal Affairs and Housing. Each letter was a brief summary of the

government funding that is being allocated to Rimbey relative to some of the capital needs of the community. Upgrades of the Town roads clearly rests with the Town Council and that the town has identified several future projects.

Mr. and Mrs. Jennings wanted to know why 51st Avenue is not set as a priority for asphalt. Mayor Barr commented that the earlier subdivisions only required a gravel standard road base. The Subdivision from 46 to 44 on 51st Avenue was built to a gravel standard and to upgrade to an asphalt standard would need to be done as a local improvement tax on the property owners in the area and requires 65% of the residences agreeing for this to happen. A local improvement tax is fair and equitable for all the home owners in Rimbey.

Mayor Barr explained that yes the funding that was mentioned in the letters is available for Rimbey, but to receive all the funding there are some conditions that are applied. The letters cover the allocation amounts but do not specify the conditions applied to receiving the money. The costs of doing asphalt and prep work are much higher than anticipated and there are many roads that are of high priority. The funding only allows for some of the many projects to be completed each year. Mr. Jennings commented that it sounds like there is not enough money to do all the work that is needed and thanked Council.

Mayor Barr thanked the area residents of 51 Avenue for coming and will review the application.

  - Replace the leaking bundle with a new one and coat the condenser box with a box liner material \$43,267.00
  - Replace the condenser with a new one @ \$42,267.00 Administration recommends a new condenser and is approaching the county to address there support.

Bylaw 814/07rezoning

Mr. Bast presented to Council a petition with 18 signatures in regards to the water pressure and dirt in water, weeds and contractor's garbage from Lot 41, Block 22, Plan 062 5710, taxes, road repair, and sidewalk repairs on 57 Avenue. Mr. Bast commented that dirt deposits have been showing up in the residential water since they started doing the subdivision. It takes forever to flush the system after a heavy piece of equipment goes by his property. The Alley that was built for the subdivision is much higher than his property and during the spring and thaw he has run off that goes into his garage. Another concern is the new subdivision is not taking care of the weeds and the garbage is being left at the site and blowing into residential property. Mr. Bast commented that the residents are not against the subdivision; just want to have things dealt with.

Mayor Barr commented that Council was unaware that there was problem with the water and the water line that feeds the area is from 57<sup>th</sup> Avenue which is in the front of the street. No other reports have been of any concern with the water have been filed. Mr. Bast was asked when this problem first occurred.

Mr. Bast commented that when a packer goes by mud gets in the water line and others have complained of a smell in their water. The deposits began after the water meters were installed in February.

Mayor Barr explained Administration and Public Works will take a look at the intersection and see what could be causing the deposits in the water line. This will be put as a priority and administration will look into the concerns that were brought up. Mr. Bast thanked council and withdrew from meeting at 6:30 pm.

This was discovered due to receiving a utility bill of \$136.00. The sewer rate is based on 80% of the water used, but the water that was leaking out of the toilet was clean water that was going in the sewer and because it was clean water Mr. Goofers does not think he should have to pay for it. Public works came out and told him that his water consumption was high and it was suggested that a plumber evaluate his system. Mr. Goofers is requesting Council forgive the \$51 dollars of sewer charge because it was clean water.

Mayor Barr commented that notices were sent out in June to people with high consumption rates that there may be problem and should be assessing their homes for possible leaks. These notices were sent out prior to the change in billing. There were many residents who were experiencing the same problems. Water that is seeping through a faulty valve in the toilet still went into the sewer and as such is treated the same way. It is impossible to measure what is clean water that goes down the sewer and once in the system all is considered the same. Council and Administration are monitoring the records all the time and letters are being sent out to high end users and there has been a very good response. Notifications will continue to be sent out to inform those people with high consumption that is above the normal range of consumption.

Mayor Barr commented that Council will be deliberating this and this is the first invoices that are based on consumption rates and there have been many repairs similar to yours that have been done and the consumption rate has already gone down.

Mr. Phil Swanson, owner of Rimbey TV, provides satellite internet to the surrounding area and is currently broadcasting off a tower that is located behind his store. Currently the location does not allow for sufficient coverage for much of the surrounding area. Mr. Swanson is asking Council to consider allowing him access to the water tower to place two antennas and two blackhaul units that are the size of a star choice satellite dish on the tower. Mr. Swanson would like to know what the town would like for use of the tower or possibly trade internet access for various locations around the town. Council would like Administration to look into Mr. Swanson's proposal and bring back a recommendation to Council.

Delegation: Parkland Airshed Management Zone – Kevin Warren Mr. Kevin Warren presented an overview of the Parkland Airshed Management Zone (PAMZ) Association's Regional Air Quality Monitoring program to Council. Mayor Barr provided a brief summary of the procedures of the meeting. All concerns will be addressed after the Applicant's presentation.

Administration noted that both bylaws have been dully advertised in local newspapers and that three written submissions opposing the

development were received from the following:

- Ms. Crystal Cummins, 5126-51 Avenue, Rimbey
- Ms. Corinne Scheetz, 4622-53 Avenue, Rimbey
- Mr. Joe Anglin, 5133-52<sup>nd</sup> Avenue, Rimbey

Mr. Peacock advised that the complexes being proposed are built to be appealing and the type of families that these units are geared to are young employed families. Due to high building costs these structures are not for low income families. The proposed 4-plex plan will be smaller than the last due to the size of the property. At this time there is no place in Rimbey that a person can do R4 development and that is why this path is being taken and he is looking for suggestions on alternative sites for starter type homes.

Mayor Barr thanked Mr. Peacock and reiterated to public attendees that the debate of this meeting is about the zoning and not about the building.

Ms. Woodliffe presented her concerns regarding parking, increased traffic flow, noise, removal of natural tree growth, and reduction in green space on the property which would take away from the appeal of the area. Ms. Woodliffe thanked Council for their time.

Mr. Moore a resident across from the proposed site presented a petition of 30 signatures from residents that are opposed to the rezoning change. The 30 signatures are concerned that if this rezoning goes thru there would be increased traffic flow, noise, destruction of mature trees, and a large height difference between a new development and the existing development in the area.

Mr. Shideler presented concerns regarding street parking for non local residents. If these units are for younger families there would be no place for a swing set for children. An increase housing density would increase the traffic flow and increase risk to kids who are out playing street hockey. Mr. Shideler feels the development is a good idea just not in an R2 area.

Mr. Woodliffe presented concerns that there would be an increase in traffic flow and people who rent these places are younger and wilder, with more vehicles being parked on the street.

Mr. Hornsey presented a petition on behalf of the neighborhood consisting of 15 signatures. Concerns brought forward were that a 4-plex would look out of place with the existing dwellings. Vehicle and pedestrian traffic is already heavy in that area due to being located near GTI and the school. Mature trees and lawn would be removed to make space for complex and parking, which would take away from the existing green space that the area has achieved.

Ms. Burrows discussed that 10 years ago she built a duplex, which was built with consideration of the existing heights of the other buildings in the area. Traffic flow is heavy in the area with a lot of delivery trucks and increased traffic to the school during week day peak hours. R4 development would not fit in with the rest of the neighborhood.

Mr. Francis commented that there is already too much traffic on the street unless they build parking within the property line.

Mayor Barr commented that R4 zoning are in short supply within the community. Council and Administration will be seeking information from the planning agency before any decisions will be made to assess the best placement of R4 zoning.

Mr. Moore commented that R4 planning would be best suited in new development areas than in the older developed areas.

Mr Peacock agreed rather that from what he is hearing from the public that R4 would be better suited in the newer development areas. The frustration is that Rimbey has a zero vacancy and no rentals and this is evident when five or six people are vying over one rental. R4 would help create the new rentals that are needed.

Mayor Barr reiterated that Council will review with the planning agency

and will issue a communiqué when a decision is made. Council will be taking time to search out additional information before making a final decision. Council thanks all for attending the public meeting.

On behalf of the residents of 52 Street and 51 Avenue area, Mr. Hornsey thanked Council for listening.
