As no positive results have occurred after we notified the owner of this problem, you have chosen to complete a Record of Disturbance. The owner has been notified that someone in the area has been issued a Record of Disturbance.

Please take a moment to review this package to ensure you'll fill it out properly.

A successful package should show:

- 1) The barking is excessive and continuous over a period of time.
- 2) The dog in question is observed barking.
- 3) You are able to describe the dog.
- 4) You can provide the exact address of where the dog resides.
- 5) The record is legible.
- 6) Each entry is made at the time the barking occurs.
- 7) The record is not altered or rewritten.

Only one person may write on a Record of Disturbance; if more people in your household want to fill out a Record, each person needs to have their own. If necessary, you may use additional paper and attach it to the Record. Completed packages can be returned to our office at 4938 – 50<sup>th</sup> Avenue, Rimbey AB. The Record of Disturbance will be reviewed by a Bylaw Officer or Peace Officer.
