

#### Background:

Oct 13, 2005 Council passed a resolution that members of the Development Appeal Board be provided an annual honorarium of \$100.00 to serve on the board. Since that time members who served on the board have received the annual honorarium of \$100.00. Any courses relating to the position being offered and the town approves, the members who attend receive reimbursement in accordance with Policy 155.
