In order to vote, you must produce identification for inspection.

The identification must be: One piece of photo identification **with name and address** that is issued by a Canadian Government (federal, provincial, local, or an agency thereof)

- Operator/Driver's License,
 - Government photo identification card (for non-drivers)
- OR

One piece of identification authorized by the Chief Electoral Officer under the Election Act **with name and address**:

Bank/Credit card statement or personal cheque, Correspondence issued by a school, college or university, Government cheque or cheque stub, Income/property tax assessment notice, Insurance policy or coverage card, Letter from a public curator, public guardian or public trustee, One of the following, issued by the responsible authority of a shelter or soup kitchen: Attestation of residence, letter of stay, admission form or statement of benefits, Pension Plan statement of benefits, contributions or participation, Residential lease or mortgage statement, Statement of government benefits, e.g. employment insurance, old-age security, social assistance, disability support or child tax benefit, Utility bill, e.g. telephone, public utilities commission, television, hydro, gas or water, Vehicle ownership or insurance certificate; Attestation of Identity and Residence issued by the authorized representative of a correctional institution; Attestation of Residence issued by the authorized representative (landlord) of a commercial property management company; Attestation of Residence issued by the responsible authority of a Supportive Living Facility,

As required by section 53 of the Local Authorities Election Act.

**Section 48, LOCAL AUTHORITIES ELECTION ACT
RSA 2000 Chapter L-21**

Rules of Residence

- 48(1) For the purposes of this Act, the place of residence is governed by the following rules:
- (a) a person may be a resident of only one place at a time for the purposes of voting under this Act;
 - (a.1) if a person has more than one residence in Alberta, that person shall, in accordance with subsection (1.1), designate one place of residence as the person's place of residence for the purposes of this Act;
 - (b) the residence of a person is the place where the person lives and sleeps and to which, when the person is absent, the person intends to return;
 - (c) a person does not lose the person's residence by leaving the person's home for a temporary purpose;
 - (d) subject to clause (e), a student who
 - (i) attends an educational institution within or outside Alberta,
 - (ii) temporarily rents accommodation for the purpose of attending an educational institution, and
 - (iii) has family members who are resident in Alberta and with whom the student ordinarily resides when not attending an educational institutionis deemed to reside with those family members;
 - (e) if a person leaves the area with the intention of making the person's residence elsewhere, the person loses the person's residence within the area.
- (1.1) For the purposes of subsection (1)(a.1), a person shall designate the person's place of residence in accordance with the following factors in the following order of priority:
- (a) the address shown on the person's driver's license or motor vehicle operator's license issued by or on behalf of the Government of Alberta or an identification card issued by or on behalf of the Government of Alberta;
 - (b) the address to which the person's income tax correspondence is addressed and delivered;
 - (c) the address to which the person's mail is addressed and delivered.
