



BY-LAW NO. 840/09

A BY-LAW OF THE TOWN OF RIMBEY, IN THE PROVINCE OF ALBERTA, FOR THE PURPOSE OF CLOSING A CERTAIN ROAD

WHEREAS

The roads hereinafter described are not required for public travel;

AND WHEREAS

Application has been made to Council to have the roadway closed;

AND WHEREAS

Council of the Town of Rimbey deems it expedient to provide for a By-Law for the purpose of closing certain roads, or portions thereof, situated in the said municipality.

AND WHEREAS

Notice of the Intention of Council to pass a By-Law has been given in accordance with Sections 22 and 606 of the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta 2000; As Amended,

NOW THEREFORE

the Council of the Town of Rimbey, duly assembled, hereby enacts as follows:

AND WHEREAS

Council was not petitioned for an opportunity to be heard by any person claiming to be prejudicially affected by the By-Law;

NOW THEREFORE BE IT RESOLVED

That the Council of the Town of Rimbey, duly assembled, hereby closes all of the portion of 49th Avenue, between 54th Street and 55th Street, as shown on 'Appendix A' as described in:

**PLAN 042 1464
ALL THAT PORTION OF 49TH AVENUE LYING WEST OF THE PRODUCTION NORTHERLY OF THE WEST BOUNDARY (HAVING A DISTANCE OF 26.84 METRES) OF 54 STREET ON SAID PLAN.**

EXCEPTING THEREOUT ALL MINES AND MINERALS


As Council has determined that it is no longer necessary for public travel owing to the existence of an alternate route.

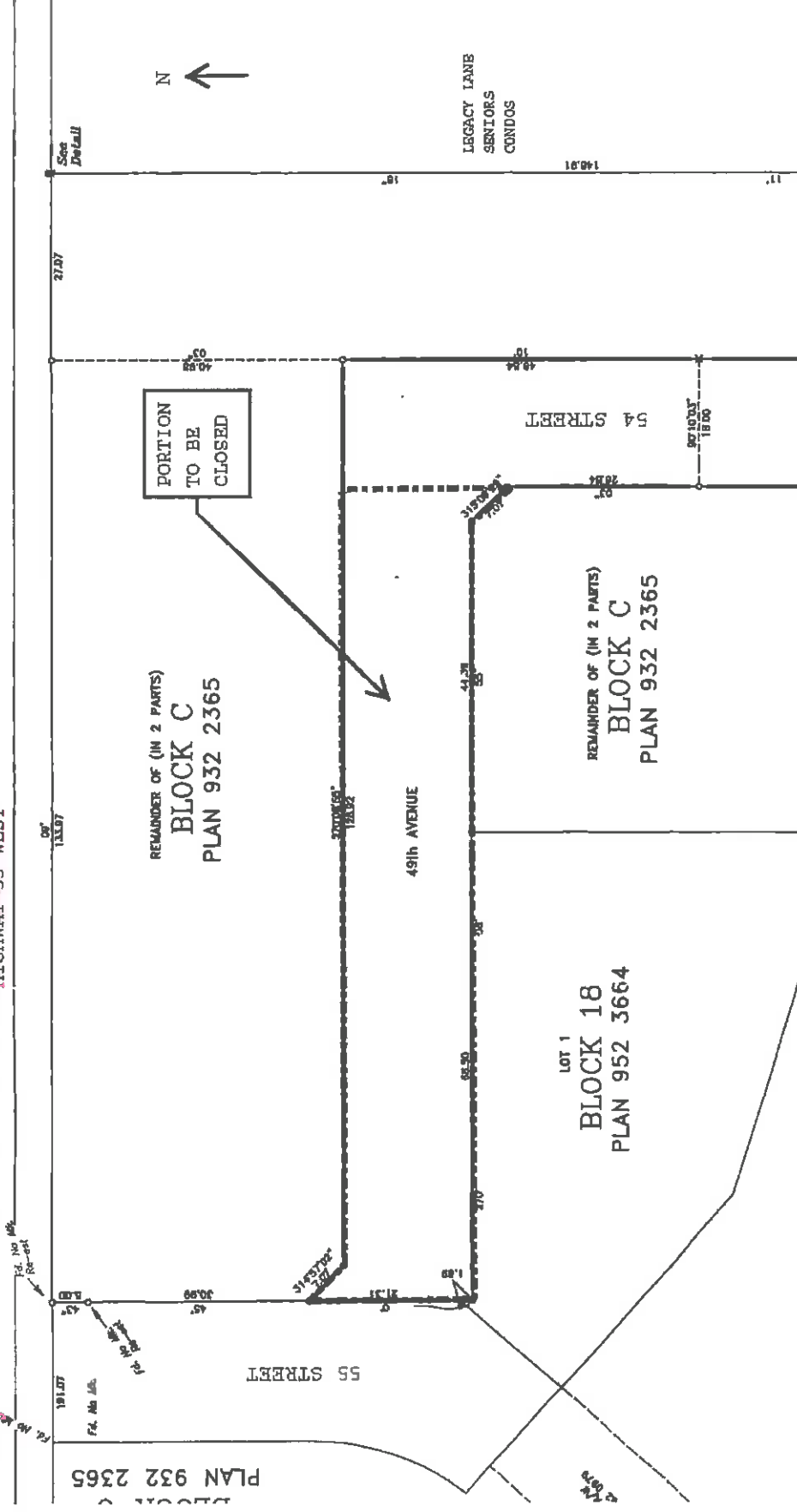
